





Public Sector Grants

- Financial award given to carry out charitable work for the public good:
 - Grantee has obligations
 - State, county, local governments and non-profit agencies
 - Designated 501(c)3 taxexempt organizations under the Internal Revenue Service (IRS) tax code



Publicly Available

- Required for nonprofit organizations and private funding organizations
- Valuable tool with a wealth of information:
 - Amount of money donated to organizations in the last tax year
 - Lists organizations and individuals who received awards
 - The amount given each award
 - Members of the Board of Directors
 - What income-producing investments the grant maker holds





Survey Participant Burden


- Analyzed number and types (nonactionable, technical, valid) of alarms sounded by technological equipment at a CA metropolitan hospital ED
- 50% decrease (pre 465, post 228)



- Many ICU patients have gaps in memory because of sedation or delirium
- Innovation grant to develop an app where families and/or patients can record daily experiences





- 1 \$15,000 Beginner or Experienced
- 3 \$30,000 Beginner or Experienced

Funder's Mission & Funding Priorities

National Institutes of Nursing Research (NINR)

- The mission of the National Institute of Nursing Research (NINR) is to promote and improve the health and quality of life of individuals, families, and communities.
- Funding Priorities
 - Symptom Science: Promoting Personalized Health Strategies
 - Wellness: Promoting Health and Preventing Disease
 - Self-Management: Improving Quality of Life for Individuals with Chronic Illness
 - End-of-Life and Palliative Care: The Science of Compassion
 - Promoting Innovation: Technology to Improve Health
 - 21st Century Nurse Scientists: Innovative Strategies for Research Careers

KP Northern California Nursing Research Community Benefit Program

- The mission of the NCNR-CB Program is to improve the health and well-being of KP members (patients) and the communities in which we live and work.
- Funding Priorities
 - Advance Medical or Healthcare Knowledge
 - Access to Care and Coverage
 - Healthy Eating and Active Living (HEAL)
 - Mental and Behavioral Health
 - Community and Family Safety
 - Economic Security

Grant Writing Proposal Mechanisms

Request for Proposal (RFP):

- Encourage proposals for a program established by the funder
- Usually no difference from guidelines issued for grants
- Funder is being proactive in soliciting proposals
- The Foundation Center maintains a free, current national list of RFPs on its website at http://www.foundationcenter.org

Grant Application or Proposal

 Fund raising from a foundation, corporation, government agency, or individual that outlines how the money will be used, what receiving the money will accomplish, and who will undertake the tasks described in the proposal

Letter of Intent (LOI)

 A Letter of Intent is basically a shortened version of your complete grant proposal. It will allow the potential donor to assess whether or not there is a good match between your project and their interests

Grant Writing Organizing Methods

- Outcomes Method
 Organizing a grant proposal that focuses on the results anticipated at the end of the project or program.
- Process Method
 Organizing a grant proposal that focuses on the way a project or program will be carried out.



Basic Components of a Grant Proposal & LOI

Grant Application

- Abstract/Summary
- Statement of Need
- Project Activity, Methodology and Outcomes
- Evaluation
- Dissemination
- Budget and Continuation Funding

Letter of Intent (LOI)

- Opening Paragraph: Your summary statement
- Statement of Need: The "why" of the project (1–2 paragraphs)
- Project Activity: The "what" and "how" of the project
- Outcomes (1–2 paragraphs)
- Credentials (1–2 paragraphs)
- Budget (1–2 paragraphs)
- Closing (1 paragraph)
- Signature



Submission Process: Paper or Online



Paper Submission

- Make the proposal easy to read
- Detail history and relationships when possible
- Present a chronological account of your organization's history
- State any connection your organization may have to the funding organization
- Make a logical presentation for the need—how will the community, members/patients, and families benefit?

- Include key staff information
- Use only relevant and necessary charts/figures/photographs
- Describe team/organizational qualifications and how they will make your project succeed
- Describe how the project will be of benefit, even if you do not succeed (e.g., create new tools or instruments, create a foundation for further research)
- Apply for Institutional Review Board (IRB) approval as research or not human subjects research



Online Submission

- Similar to paper submission, but prepare separate draft online
- Work within the guidelines and limitations
- Make information clear, concise, and easy to understand
- Use as many parts of a paper submission as possible
- Copy and paste final draft when ready





To Write a Successful Grant

Rather than focus on what you need to accomplish your project, focus on:

- How your project will further the funding organization's mission
- How your project is a good fit for the funding organization's priorities
- Be mindful the grant reviewers may not know your area of clinical expertise provide context, avoid acronyms and "jargon"
- A grant writer's most important skills are knowledge and passion
- Time takes time: From concept to receiving grant check can take 6 months to a year — or longer
- Do not be force yourself to meet an arbitrary deadline If it is not ready, it is always best to wait until you get it right
- Reviewers do not forget past grant submissions, especially if they were inappropriate to the organization's mission, disorganized, contained misspellings or did not follow the guidelines

What Grant Reviewers Look For

- With limited staff and time, funders do what they can to narrow the field of applicants ASAP
- First rule of grant writing: Follow instructions
- Usually restrict the number of words, number of pages, margins, font, point-type size, paper clipped or stapled
- Even if they ask for parts of an application typed on a typewriter find one and do it!

- Is there a good match between their funding interests and your proposal?
- Grant writing is not about luck or multiple submissions
- Grant writing is about research and focused writing
- Follow each funder's instructions, no matter how trivial they seem or how much they restrict your creativity
- Funders interests must reasonably include your project
